PROCLAMATION

Declaration of the Honorary Co-Naming of C Street Southwest as INTEGRIS WAY

In the City of Miami, Ottawa County, Oklahoma

WHEREAS, INTEGRIS Miami Hospital was established on July 1, 1919 as the Miami Baptist Hospital to provide quality health care in Northeast Oklahoma while providing “service with a heart”; and

WHEREAS, INTEGRIS Miami Hospital provides hundreds of thousands of dollars in charity care and uncompensated care to the community; and is one of the largest supporters of local schools, non-profit organizations and community events; and


WHEREAS, INTEGRIS Miami Hospital is supported by the INTEGRIS Miami Foundation, which provides free mammograms to women in need and has supported the hospital with a multitude of generous donations; and

WHEREAS, INTEGRIS Miami Hospital is also supported by the INTEGRIS Miami Volunteer Auxiliary who has made significant investments to improve patient care and the patient experience; and
