(1)Should the city council find that an immediate emergency exists, which findings shall be entered in the minutes of the city council, by reason of which an immediate outlay of city funds, in an amount in excess of the limit set in section 2-118 hereof, is necessary in order to avoid loss of life, substantial damage to property or damage to the public peace or safety, then such contracts may be made and entered into without public notice or competitive bids.
