

RESOLUTION NO. CC2022-02

RESOLUTION CALLING FOR, PROCLAIMING AND ORDERING A NONPARTISAN GENERAL ELECTION IN THE CITY OF MIAMI, COUNTY OF OTTAWA, STATE OF OKLAHOMA ON TUESDAY, APRIL 5TH, 2022, FOR THE PURPOSE OF ELECTING THE COUNCIL MEMBERS FOR WARD 1 (NE) AND WARD 2 (NW).

WHEREAS, the City of Miami, by and through the City Council and pursuant to the City Charter of the City of Miami, Oklahoma and State Statutes, is hereby required to hold a general election; and

WHEREAS, 2022 is the year to call for a general election of the municipal office of the Council Member for Ward 1 (NE) and for Ward 2 (NW); and

WHEREAS, the term for the office of Council Member for Ward 1 (NE) and Ward 2 (NW) shall begin on May 2, 2022 and end at the first regular meeting of the City Council in May, 2025.

NOW THEREFORE, be it resolved by the Mayor and City Council of the City of Miami, Ottawa County, Oklahoma:

The City Council calls for, proclaims and orders a general, nonpartisan election for Tuesday, April 5, 2022, conducted by the Ottawa County Election Board, for the purpose of electing a Council Member for Ward 1 (NE) and Ward 2 (NW) of the City of Miami, Oklahoma, for a term of three (3) years. The filing dates for this election are February 7, 8, and 9, 2022, between the hours of 8:00 a.m. and 5:00 p.m., with the contest of candidacy and the withdrawal period on February 10 and 11, 2022, between the hours of 8:00 a.m. and 5:00 p.m., at the Ottawa County Election Board office, Ottawa County Courthouse Annex. The Council Members terms will commence on the 2nd day of May 2022 and end as of the first regular meeting of the City Council in May, 2025. All candidates must be registered voters and residents of the City of Miami for at least two years next preceding the election and be registered at an address within the respective Ward 1 (NE) and Ward 2 (NW) for at least six (6) months prior to the filing of the declaration of candidacy, and all qualified electors of Ward 1 (NE) and Ward 2 (NW) may vote for each respective elected office.

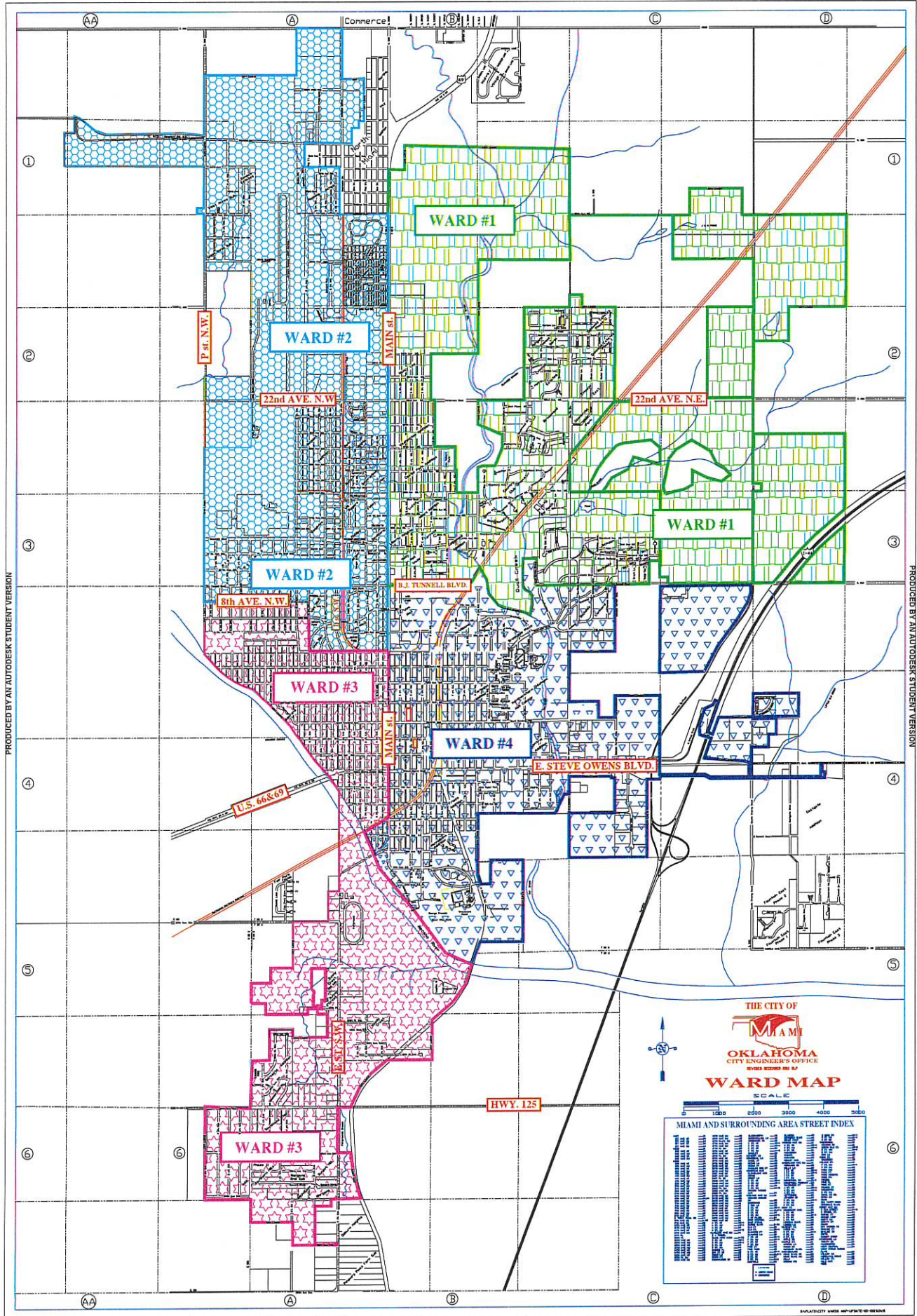
